PARTIAL REMOVAL OF A DESIGNATION UNDER SECTION 182 OF THE RESOURCE MANAGEMENT ACT 1991

Partial removal of Designation 6706 State Highway 1 – Takanini to Drury and Designation 6714 State Highway 1 – Manukau City Centre to Takanini, in the Auckland Unitary Plan (Operative in Part)

Summary

Auckland Council has received a request from Waka Kotahi NZ Transport Agency (**Waka Kotahi**) under section 182 of the Resource Management Act 1991 (**RMA**), to remove in part two designations in the Auckland Unitary Plan (Operative in Part) (**AUP**). These designations are:

- Designation 6706 State Highway 1 Takanini to Drury (remove from 71 properties)
- Designation 6714 State Highway 1 Manukau City Centre to Takanini (remove from 18 properties)

This section 182 request is dated 3 August 2020. The section 182 request is included in **Attachment A**.

A section 182(1) request is required to uplift the existing designation in part from land which is no longer required for the purpose of the designation by NZTA.

Auckland Council, as the territorial authority, is required to amend its district plan, without using the process in Schedule 1, as soon as reasonably practicable after receiving a section 182 request unless it considers that the effect of the removal of part of the designation on the remaining designation is more than minor.

It is recommended that the partial removal be accepted.

Recommendation

- 1. That the section 182 request from Waka Kotahi for the partial removal of Designations 6706 and 6714, from 89 properties, in the Auckland Unitary Plan be **accepted** for the following reasons:
 - The extent of Designation 6706 that applies to the properties listed in Attachment B, is no longer required in respect of Waka Kotahi's current or future motorway requirements for State Highway 1 (Takanini to Drury); and

- The extent of Designation 6714 that applies to the properties listed in Attachment C, is no longer required in respect of Waka Kotahi's current or future motorway requirements for State Highway 1 (Manukau City Centre to Takanini).
- The effects of the partial removal of the designations will not be more than minor.
- 2. That Designations 6706 and 6714 be partially removed from the 89 properties as listed in Attachments B and C, and as shown in Attachment D, as soon as reasonably practicable, in the Designation Overlay in the Auckland Unitary Plan (Operative in Part) GIS Viewer.

2.0 BACKGROUND

2.1 Details of designation

Designation 6706 State Highway 1 applies to multiple properties from north of Takanini interchange to south of Quarry Road, Drury. The purpose of this designation is for motorway purposes Auckland – Hamilton. The lapse date is when "given effect to" (i.e. no lapse date) and there are no conditions listed for this designation. This designation is a rollover of Designation 201 from Auckland Council District Plan (Papakura Section) 1999.

Designation 6714 State Highway 1 applies to multiple properties from north of Highbrook Drive, Otara to south of Great South Road, Takanini. The purpose of this designation is for the Southern Motorway (State Highway 1). The lapse date is when "given effect to" (i.e. no lapse date). This designation is a rollover of Designation 186 from Auckland Council District Plan (Manukau Section) 2002.

Condition 3 of Designation 6714 states:

As soon as practicable following completion of the Southern Corridor Improvements (the Project), the Requiring Authority shall give notice in accordance with 182 of the RMA to Manager Regional and Local Planning, Auckland Council, for the removal of those parts of the designation that are not required for the long term operation, maintenance and mitigation of effects of the Project.

2.2 Land affected by removal

Waka Kotahi has provided a list of properties where Designation 6706 is no longer required for their work programme for State Highway 1 (refer to Attachment B). This list consists of 71 properties.¹ These properties are either zoned Residential – Mixed Housing Suburban or Residential – Mixed Housing Urban. The designation currently applies to a part of each of these properties.

Waka Kotahi has provided a list of properties where Designation 6714 is no longer required for their work programme for State Highway 1 (refer to Attachment C). This list consists of 18 properties. Two of these properties are zoned Open Space – Informal Recreation and the designation currently applies to the entirety of the sites. The remaining properties are zoned Residential – Mixed Housing Suburban and the designation currently applies to part of each site.

¹ Note: initial section 182 request from Waka Kotahi requested that the designations be removed from a total of 93 properties. However, the list of properties supplied included some properties that the designations did not currently apply to in the AUP. Waka Kotahi provided an updated list which contained 89 properties.

Waka Kotahi has provided a series of site plans showing the extent of Designations 6706 and 6714 that is requested to be removed (refer to Attachment D). They have also provided individual maps of these sites (refer to Attachment D).

All other properties not identified by the section 182 request would remain within the extent of the designations.

2.3 Consultation

Waka Kotahi has advised that the owners of the properties where the designation is requested to be removed have been contacted and informed of the section 182 request. These properties are listed in Attachments B and C.

2.4 Delegated authority to consider alterations to designations

The Team Leader – Planning Central and South (Plans and Places Tier 5) has delegated authority, in accordance with Schedule 2A of the Auckland Council Delegations: Chief Executive Officer (updated February 2017), to exercise the Council's functions, powers, duties and discretions under the Resource Management Act 1991 in relation to Section 182 to approve a removal of a designation.

The section 182 request to remove the designation can therefore be considered by the Team Leader – Central and South and can be accepted or declined.

2.5 Relevant Statutory Provisions

Section 182 of the RMA allows a requiring authority to remove a designation or part of a designation if it no longer considers it be necessary. This section also applies to a notice by a territorial authority, to withdraw its own designation or part of a designation within its own district.

Section 182(2) states that as soon as reasonably practicable the territorial authority shall, without using the process in Schedule 1, amend its district plan accordingly. If the territorial authority considers that the effect of the removal of part of a designation on the remaining designation is more than minor, it may, within 20 working days of receipt of a section 182 notice, decline to remove that part of the designation.

It is considered that Waka Kotahi has provided sufficient justification for the partial removal of Designations 6706 and 6714 for the following reasons:

- The extent of the designations that apply to the properties identified in Attachments B and C and shown in Attachment D are no longer required in respect of Waka Kotahi's current and future requirements for State Highway 1; and
- The effects of the partial removal will not be more than minor.

3.0 RECOMMENDATION

That pursuant to Section 182 of the Resource Management Act 1991 that the partial removal of Designation 6706 State Highway 1 (Takanini to Drury) and 6714 State Highway 1 (Manukau City Centre to Takanini) be **ACCEPTED** and the Auckland Unitary Plan Operative in part be amended accordingly.





Attachment D: Part Removal of Designation Plan series and maps of individual sites – extent of designations to be removed




