I seek your approval of this plan modification pursuant to clause 20A, first schedule, Resource Management Act 1991.



Schedule 2A of the Auckland Council Combined Chief Executives Delegation Register. authorises all powers, functions, and duties under RMA's first schedule (except clause 17 which cannot be delegated) to tier four positions.

Nature of change	A Clause 20A modification is required to correct the GIS Viewer in the AUP to fully implement the decision of Plan Change 40, namly to include the location of Matakana Link Road / Te Honohono ki Tai as a Arterial Road Control as shown on Map 3 of the plan change decision (at Appendix 1, Page 5).
Effect of change	The change is to correct a minor omission that occurred when Plan Change 40 was made operative. The change is neutral as it would not affect the rights of any members of the public, being simply to implement the decision of Plan Change 40 correctly.
Changes required to be made (text/in-text diagrams)	No change proposed to the text of the Operative in Part version.
Changes required to be made (maps)	Amend the 'Arterial Roads' layer under the 'Controls' layer in the AUP GIS Viewer to add the Matakana Link Road / Te Honohono ki Tai.




Map 3 - Control: Height Variation Control, and Arterial Roads
