
Subject: **Plan Modification: Clause 20A Amendment to Chapter E26 of the Auckland Unitary Plan (AUP) Operative in part (15 November 2016).**

Delegated authority to T4 manager through Schedule 2A of the Auckland Council Combined Chief Executives Delegation Register (Updated May 2017).

This plan modification requires decision-making pursuant to clause 20A of the First Schedule to the Resource Management Act 1991, as corrections are required to the Auckland Unitary Plan (Operative in Part).

Nature of change	<p>A change is required to correct spelling mistakes within Chapter E26 of the Operative in Part version.</p> <p>Discussion</p> <p>The three earthworks standards relating to kauri dieback disease within Chapter E11 Land Disturbance - Regional (including the two proposed as part of Plan Change 14) refer to a specifically defined area as singular (“that area”), whereas the two same standards within Chapter E26 Infrastructure refer to this area in the plural form (“that areas”). The change is to remove the plural ‘s’ from the two standards in Chapter E26 to correct these spelling errors.</p>
Effect of change	The changes are minor in nature and therefore do not change the application or intent of the provisions.
Changes required to be made	<p>Amend two standards in Chapter E26 in the Operative in Part version as per below:</p> <p>Standard E26.5.5.2(8):</p> <p>(8) To prevent the spread of contaminated soil and organic material with kauri dieback disease, vehicle and equipment hygiene procedures must be adopted when working within 3 times the radius of the canopy drip line of a New Zealand kauri tree. Soil and organic material from land disturbance within 3 times the radius of the canopy drip line must not be transported beyond that area unless being</p>

	<p>transported to landfill for disposal.</p> <p>Standard E26.6.5.2(13):</p> <p>(13) To prevent the spread of contaminated soil and organic material with kauri dieback disease, vehicle and equipment hygiene procedures must be adopted when working within 3 times the radius of the canopy drip line of a New Zealand kauri tree. Soil and organic material from land disturbance within 3 times the radius of the canopy drip line must not be transported beyond that area unless being transported to landfill for disposal.</p>
