

CONSENT ORDER

- [A] Under s 279(1)(b) of the Resource Management Act 1991, the Environment Court, by consent, orders that:
 - (1) the appeal is allowed subject to the amendments set out in this order;
 - (2) the appeal is otherwise dismissed.
- [B] Under s 285 of the Resource Management Act 1991, there is no order as to costs.



REASONS

Introduction

- [1] This consent order relates to an appeal against part of a decision of the Auckland Council in respect of a submission lodged by Auckland Hebrew Congregation on proposed Plan Change 10: Historic Heritage Schedule (errors, anomalies and information update) (PC10) to the Auckland Unitary Plan Operative in part (AUP).
- [2] The land and buildings at 108 Greys Avenue, Auckland comprise the Auckland Synagogue and community centre owned by the Auckland Hebrew Congregation.
- [3] The Auckland Synagogue is shown on the planning maps of the AUP as subject to Chapter D9, Historic Heritage Overlay. It is identified as Historic Heritage Place ID#01965 and as a Category B Historic Heritage Place.
- [4] Schedule 14.1 of the AUP sets out 11 descriptive headings that provide information about the Historic Heritage Places identified in the Historic Heritage Overlay.
- [5] PC10 proposed various amendments in relation to Schedule 14.1 in the AUP in relation to Historic Heritage Place ID# 01965, with amendments to the description, details of the primary feature, listed heritage values, exclusions and extent of place.
- [6] The Auckland Hebrew Congregation's appeal related to the following three headings in Schedule 14.1:
 - (a) Heritage Values identification, in particular whether the Auckland Synagogue exhibits Heritage Values E(technology), G (aesthetic)and H (context);
 - (b) Extent of Place description (including Schedule 14.3); and



- (c) Exclusions description.
- [7] On 27 November 2019 expert witness conferencing occurred between the parties' heritage experts. The matters agreed between the experts have provided the basis upon which the parties have reached an agreement to resolve this appeal.
- [8] Specifically, the parties have agreed that the appeal can be disposed of by amending PC10 to modify Schedule 14.1 in the AUP in relation to Historic Heritage Place ID# 01965 as follows:
 - (a) Deleting 'G' and 'H' from the Heritage Values identification column;
 - (b) Deleting the reference to 'and Schedule14.3' from the Extent of Place description column;
 - (c) Deleting the existing Exclusions description and replacing it with the following description:

Extension to the primary feature; interior of main synagogue, except 1968 roof/ceiling structure and form; interior of basement level, except stairwell and safe; restrooms/changing rooms for upper level hall/gymnasium

Post 1968 extensions to primary feature; interior of building except:

- 1.Basement stairwell
- 2. Ground floor minor synagogue, café (former library), stairwell, foyer, original entrance columns, and void space of entrance
- 3. First floor gymnasium and raised adjoining space (former social hall), stairwell, foyer, and balconies.

And by modifying Schedule 14.3 in relation to Historic Heritage Place ID#01965 as follows:



- (d) Deleting Map 14.3.13.1 Schedule ID1965 -Auckland synagogue and community centre-Ground Level, Map 14.3.13.2 Schedule ID 1965 Auckland synagogue and community centre -Upper Level, and Map 14.3.13.3 Schedule ID 1965 -Auckland synagogue and community centre -Basement Level.
- [9] The parties agree that the proposed amendments to Schedule 14.1 of the AUP appropriately protect the identified heritage values of the Auckland Synagogue.
- [10] In making this order the Court has read and considered the appeal and the joint memorandum of the parties dated 28 February 2020.
- [11] No other person has given notice of an intention to become a party to the proceedings under s 274 of the Act.
- [12] The Court is making this order under s 279(1)(b) of the RMA, such order being by consent, rather than representing a decision or determination on the merits pursuant to s 297 of the RMA. The Court understands for present purposes that:
 - (a) All parties to the appeal have executed the memorandum requesting the order.
 - (b) All parties are satisfied that all matters proposed for the Court's endorsement fall within the Court's jurisdiction, and conform to the relevant requirements and objectives of the RMA, including in particular Part 2.

Order

- [13] Therefore, the Court orders, by consent, as set out in **Appendix 1** to this consent order that PC 10 is amended to modify Schedule 14.1 in the AUP in relation to Historic Heritage Place ID# 01965 by:
 - (a) Deleting 'G' and 'H' from the listed Heritage Values identification column;
 - (b) Deleting the reference to 'and Schedule 14.3' from the Extent of Place description column



(c) Deleting the existing Exclusions description and replacing it with the following description:

> Extension to the primary feature; interior of main synagogue, except 1968 roof/ceiling structure and form; interior of basement level, except stairwell and safe; rest rooms/changing rooms for upper level hall/gymnasium

> Post 1968 extensions to primary feature; interior of building except:

- 1. Basement stairwell
- 2. Ground floor minor synagogue, café (former library), stairwell, foyer, original entrance columns, and void space of entrance
- 3. First floor gymnasium and raised adjoining space (former social hall), stairwell, foyer, and balconies.

And Schedule 14.3 in the AUP in relation to Historic Heritage Place ID# 01965 is to be modified by:

- Deleting Map 14.3.13.1 Schedule ID 1965 Auckland synagogue (d) and community centre - Ground Level, Map 14.3.13.2 Schedule ID 1965 - Auckland synagogue and community centre - Upper Level, and Map 14.3.13.3 Schedule ID 1965 - Auckland synagogue and community centre - Basement Level.
- The appeal is otherwise dismissed. [14]
