Auckland Unitary Plan (AUP) Operative in part (15 November 2016).

Delegated authority to T4 manager through Schedule 2A of the Auckland Council Combined Chief Executives Delegation Register (Updated May 2017).

This plan modification requires decision-making pursuant to clause 20A of the First Schedule to the Resource Management Act 1991, as corrections are required to the Auckland Unitary Plan (Operative in Part).

Nature of change	A minor change is required to correct text under I432.6.5 - Table 3 Schedule of Coordinates to the Operative in Part version.						
	Discussion As directed by the national planning standards data standards on the 14 May 2021 council amended the Auckland Unitary Plan (Operative in Part)(AUP) to ensure it is compliant with New Zealand Vertical Datum 2016 (NZVD2016) and all coordinates are in terms of New Zealand Transverse Mercator 2000 (NZTM2000). An error has since been identified in the heading of a column in I432.6.5 Pūkaki Marae – Matukutureia viewshaft, Table 3 Schedule of Coordinates. The table uses the correct coordinate system but the column heading incorrectly references an historical system that is no longer used. This error needs to be corrected to reference the correct system and also ensure consistency with the directions outlined above.						
Effect of change	The change is minor in nature. The amendment does not change the application of intent of the provisions.
