Removal of a designation under section 182 of the Resource Management Act 1991

Partial removal of Designation 8528: Massey North Underground Electricity Transmission Cables in the Auckland Unitary Plan (Operative in Part).

Summary

Auckland Council has received a request from Transpower New Zealand Limited under section 182 of the Resource Management Act 1991 (RMA), dated 4 October 2022 to remove in part Designation 8528 Massey North Underground Electricity Transmission Cables.

A section 182(1) request is required to uplift the existing designation in part from land which has been deemed to be 'no longer required' by Transpower New Zealand Limited.

Auckland Council, as the territorial authority, is required to amend its district plan, without using the process in Schedule 1, as soon as reasonably practicable after receiving a Section 182 request unless it considers that the effect of the removal of part of the designation on the remaining designation is more than minor.

It is recommended that the partial removal of Designation 8528 Massey North Underground Electricity Transmission Cables be accepted.

Recommendation

- That the section 182 request from Transpower New Zealand Limited (Transpower) for the removal of part of Designation 8528 Massey North Underground Electricity Transmission Cables in the Auckland Unitary Plan be accepted for the following reasons:
 - Transpower is in the process of decommissioning and dismantling the Albany-110kV overhead transmission line. This includes the two Cable Termination Stations at either end of underground cable (at the northern and southern ends of the designation
 - Transpower no longer requires three parcels of land as part of the designation.
- 2. That Designation 8528 Massey North Underground Electricity Transmission Cables be removed in part as soon as reasonably practicable, in the GIS viewer map designation layer and
- 3. That Designation 8528 Massey North Underground Electricity Transmission Cables (location) be amended in Chapter K Designations in the Auckland Unitary Plan.

2.0 Background

2.1 Details of designation

Designation 8528: Massey North Underground Electricity Transmission Cables was rolled over from the legacy Auckland Council District Plan (Waitākere Section) 2003 into the Auckland Unitary Plan.

1.2 Land affected by removal

The designation is currently shown in the AUP maps as follows:




Figure 1: AUP(OP) GIS Viewer map of Designation 8528 (outlined in blue). The areas affected by the section 182 uplift are as shown at the north and south of the existing designation.

Transpower has provided land requirement plans showing the areas of the designation which are to be removed (refer to **Attachment C**). Figure 2 below shows the three parts of the designation subject to the section 182 request.



Figure 2: Affected land parcels at 22 Northside Drive (left) and 15 Westgate Drive (right) shown as red coloured areas (Source: Transpower s182 Removal Notice – Attachment C – Albany-Henderson Cable Designation).

Transpower is in the process of decommissioning and dismantling the Albany – Henderson 110kV transmission line. This includes the two cable termination stations at either end of the underground cable section through Westgate shopping centre.

Two of the three parcels of land (Lot 1 DP 449975 - 22 Northside Drive, Whenuapai, Lot 1 DP 449374, Lot 2 DP 449374 – 15 Westgate Drive, Massey) which are to be removed from the designation are in Transpower's legal ownership. Transpower's intention, as the legal owner of Lot 1 DP 449975 and Lot 1 DP 449374, is to reinstate and sell the land parcels that relate to these assets. The other part of the designation to be removed (Lot 2 DP 449374) is owned by Westgate Properties (2017) Limited.

Transpower has given written notice to Auckland Council – Land Advisory Services, Property and Commercial Business, Parks and Community Facilities (Auckland Council - Land Advisory Services) and Westgate Properties (2017) Limited to advise of the partial removal of Designation 8528.

1.3 Delegated authority to consider alterations to designations

The Team Leader - Regional, North, West and Islands Planning (Plans and Places Tier 5) has delegated authority, in accordance with Schedule 2A of the Auckland Council Delegations: Chief Executive Officer (updated May 2022), to exercise the Council's functions, powers, duties and discretions under the Resource Management Act 1991 in relation to Section 182 to approve a removal of a designation.

The section 182 request to remove the three areas of the designation can therefore be considered by the Team Leader – Regional, North, West and Islands Planning (Plans and Places Tier 5) and accepted or declined.

1.4 Relevant Statutory Provisions

Section 182 of the RMA allows a requiring authority to remove a designation or part of a designation if it no longer wants it. This section also applies to a notice by a territorial authority, to withdraw its own designation or part of a designation within its own district.

If a requiring authority no longer wants a designation, it shall give notice in the prescribed form to:

- the territorial authority concerned
- every person who is known by the requiring authority to be the owner and occupier of any land to which the designation relates
- every other person, who in the opinion of the requiring authority, is likely to be affected by the designation.

Section 182(2) states that as soon as reasonably practicable the territorial authority shall, without using the process in Schedule 1, amend its district plan accordingly. If the territorial authority considers that the effect of the removal of part of a designation on the remaining designation is more than minor, it may, within 20 working days of receipt of a section 182 notice, decline to remove that part of the designation (s182(5)).

The removal of a designation is an administrative process. The statutory requirement is for the requiring authority to give notice that it no longer wants a designation.

Transpower has given notice to Auckland Council, under section 182, that it no longer requires part of Designation 8528. Transpower requests that Auckland Council amend the AUP accordingly.

Transpower has also given notice to Auckland Council and Westgate Properties (2017) Limited as the owner and occupier of land affected by the partial removal of the designation.

In regard to section 182(5), Auckland Council, as the territorial authority, can decline to remove part of a designation if it considers 'the effect of the removal of part of the designation on the remaining designation is more than minor'.




Figure 3: 20 Northside Drive and extent of Designation 8528

While not a statutory requirement of section 182, Auckland Council – Land Advisory Services were contacted as part of the processing of the section 182. The aim of this was to seek their views and to ascertain whether there had been any discussion with Transpower in regard to the partial removal of the designation at 22 Northside Drive, Westgate (Lot 1 DP 449976) (see Figure 3 below outlined in purple with a blue dot).

Auckland Council – Land Advisory Services, advised in an email dated 18 October 2022 that 'it does not affect us as the parts to uplift were elsewhere and the designation on our land wasn't changing'.

At this location, the parcel of land subject to the section 182 notice is surrounded by Auckland Council owned land (20 Northside Drive, Westgate) with a larger area of land being subject to Designation 8528 (see Figure 2 above). The removal of the designation from Lot 1 DP 449976 creates a vacant space within the designation. While there is no obligation for Auckland Council to purchase the parcel of land, I consider that it could be problematic if Transpower sold their parcel of land to anyone other than Auckland Council as stated in its section 182 request. I sent a further email to Auckland Council - Land Advisory Services on 28 October 2022. This email advised that that while the designation was not being uplifted from Auckland Council owned land, it was to be uplifted from a land parcel surrounded by land owned by Auckland Council.

Auckland Council – Land Advisory Services responded, in an email of the same date, that 'the removal of the designation places no obligation on Transpower to sell the land, nor on the council to purchase it' and that they 'appreciated the diligence and concern for council's landowner interest. In this case we have no further concerns.'

Conclusion

Given the discussion above, it is considered that Transpower has provided sufficient justification for the partial removal of Designation 8528: Massey North Underground Electricity Transmission Cables for the following reasons:

- Transpower is in the process of decommissioning and dismantling the Albany-110kV overhead transmission line. This includes the two Cable Termination Stations at either end of underground cable (at the northern and southern ends of the designation)
- Transpower no longer requires these parts of the designation.

2.0 Recommendation

That pursuant to Section 182 of the Resource Management Act 1991 that the partial removal of Designation 8528: Massey North Underground Electricity Transmission Cables be **accepted** and the Auckland Unitary Plan (Operative in part) designation layer and text in Chapter K Designations be amended accordingly.



8528 Massey North Underground Electricity Transmission Cables

Purpose

Electricity transmission - the Massey North Underground Cable Project, comprising a 110kV underground transmission line for the conveyance of electricity and ancillary structures associated with the works to be located between existing Towers 6 and 12 of the Albany – Henderson A 110kV overhead transmission line.

Conditions

1. Appropriate sedimentation and erosion control measures shall be employed for any earthworks on the designated site.

2. "Works" has the same meaning as in the Notice of Requirement by Transpower New Zealand Limited for a designation for "Underground Transmission Line" dated January 2011 ("Notice of Requirement"). Works shall be conducted and maintained generally in accordance with the information provided by the requiring authority as shown on all information and plans titled: a. Form 18 titled 'Notice of Requirement by Transpower New Zealand Limited for designation for "Underground Transmission Line', signed by Brian Warburton – Environmental Strategy and Approvals Group, Transpower NZ Ltd

b. Plan Prepared by Beca, titled 'Massey North Underground Cable Project: Land Requirement Plan'
Dwg no. GIS-4213785-2-1, GIS-4213785-2-2, GIS-4213785-2-3 all Rev 1.1, all dated 27/05/2011
c. Documentation from Beca titled 'Notice of Requirement for a Designation: Massey North
Underground Cable Project' dated April 2011

d. Letter from Andrew Renton of Transpower titled 'Transpower Approval of Works within Massey North Underground Cable Designation' dated 23 September 2011.

e. Letter from Alan Wallace of Auckland Transport titled 'Transpower Approval of Works within Massey North Underground Cable Designation v2' dated 28 September 2011.

Advice Note

1. Where section 176 approvals under the Resource Management Act 1991 are required by utility operators (other than the Requiring Authority) for their works within the designation, the Requiring Authority will provide a timely response, in order to facilitate co-ordination of section 176 approvals sought by the utility operator and the road opening notice process.
