Subject: Plan Modification: Clause 20A modification to Auckland Unitary Plan

Corrections are required to the Auckland Unitary Plan (Operative in Part) 2016 (the AUP).

I seek your approval of this plan modification pursuant to clause 20A, first schedule, Resource Management Act 1991.

You have delegated authority, as a tier four manager, to make a decision to correct an error to an operative plan under clause 20A. Schedule 2A of the Auckland Council Combined Chief Executives Delegation Register¹ authorises all powers, functions, and duties under RMA's first schedule (except clause 17 which cannot be delegated) to tier four positions.

Nature of change	A Clause 20A modification is required to correct the entry for Kaukapakapa hall, library and war memorial (ID 00430) in Schedule 14.1 Schedule of Historic Heritage in the AUP. Discussion The wording for the exclusions for ID 00430 is erroneously in the column relating to "Additional Rules for Archaeological Sites or Features" instead of the "Exclusions" column to the left. This is an error and needs to be corrected. The exclusions wording was updated from "Interior of building(s)" to "Interior of building(s), except interior of library; buildings and structures that are not the primary feature; ramps and railings attached to hall and library" in Plan Change 27 which became operative in part in September 2020. The excerpt below shows clearly where the wording (highlighted) needed to go (a larger version is shown in Attachment 1).
