Summary

Auckland Council has received a request from KiwiRail Holdings Limited under section 182 of the Resource Management Act 1991 (RMA), dated 17 August 2023, to remove part of Designation 6304: Onehunga Branch Railway Line.

A section 182(1) request is required to uplift the existing designation in part from land which has been deemed surplus by KiwiRail Holdings Limited.

Auckland Council, as the territorial authority, is required to amend its district plan, without using the process in Schedule 1, as soon as reasonably practicable after receiving a Section 182 request unless it considers that the effect of the removal of part of the designation on the remaining designation is more than minor.

It is recommended that the partial removal be accepted.

Recommendation and Reasons

- That the section 182 request from KiwiRail Holdings Limited for part of Designation 6304: Onehunga Branch Railway Line to be removed from land described as Section 1 Survey Office Plan 461472 in the Auckland Unitary Plan be accepted for the following reasons:
 - KiwiRail Holdings Limited has advised that this land is no longer required for railway purposes and is surplus to its requirements.
- 2. That as soon as reasonably practicable, Designation 6304: Onehunga Branch Railway Line in the Designation overlay of the Auckland Unitary Plan be partially up-lifted, to the extent that the designation notation currently shown on Section 1 Survey Office Plan 461472 (part of 2-8 Maurice Road) is removed.

2.0 Background

2.1 Details of designation

Designation 6304: Onehunga Branch Railway Line is identified in the Auckland Unitary Plan (AUP) in Chapter K Designations, Designation Schedule for KiwiRail Holdings Limited:



Purpose

The purpose of the designation is to develop, operate and maintain railways, railway lines, railway infrastructure, and railway premises as defined in the Railways Act 2005.

Designation 6304 is currently shown on part of 2-8 Maurice Road in the AUP GIS maps as follows:



1.2 Land affected by removal

KiwiRail Holdings Limited has provided a legal description outlining the part of the designation which is to be partially removed.

The legal description of the property from which the designation is <u>to be removed</u> is: Section 1 Survey Office Plan 461472, comprising 3,017m² of land at 2-8 Maurice Road.

1.3 Delegated authority to consider alterations to designations

The Team Leader, Planning – Central/South (Plans and Places Tier 5) has delegated authority, in accordance with Schedule 2A of the Auckland Council Delegations: Chief Executive Officer (updated May 2022), to exercise the Council's functions, powers, duties and discretions under the Resource Management Act 1991 (RMA) in relation to Section 182 to approve a removal of a designation.

The section 182 request to remove the designation can therefore be considered by the Team Leader, Mr Marc Dendale (Plans and Places Tier 5), and accepted or declined.

1.4 Relevant Statutory Provisions

Section 182 of the RMA allows a requiring authority to remove a designation or part of a designation if it no longer wants it. This section also applies to a notice by a territorial authority, to withdraw its own designation or part of a designation within its own district.

Section 182(2) states that as soon as reasonably practicable the territorial authority shall, without using the process in Schedule 1, amend its district plan accordingly. If the territorial authority considers that the effect of the removal of part of a designation on the remaining designation is more than minor, it may, within 20 working days of receipt of a section 182 notice, decline to remove that part of the designation.

It is considered that KiwiRail Holdings Limited has provided sufficient justification for the partial removal of Designation 6304: Onehunga Branch Railway Line for the following reasons:

- Section 1 Survey Office Plan 461472 (the designated land) is owned by Maurice Holdings Limited and is now deemed surplus by KiwiRail for railway purposes.
- The removal of Designation 6304 from Section 1 Survey Office Plan 461472 will have no impact on the operation of the remainder of the designation.
- The removal of Designation 6304 from Section 1 Survey Office Plan 461472 solely affects Maurice Holdings Limited (the property owner), who supports and has requested the removal of the designation from 2-8 Maurice Road.

2.0 Recommendation

That pursuant to Section 182 of the Resource Management Act 1991 that the partial removal of Designation 6304: Onehunga Branch Railway Line from the land described as Section 1 Survey Office Plan 461472 be **accepted** and the Auckland Unitary Plan (Operative in part) designation overlay be amended accordingly.

KiwiRail Holdings Limited (KiwiRail) wishes to give notice that it requires part of designation: 6304 Onehunga Branch Railway Line for railway purposes to be removed from land at 2-8 Maurice Road, Penrose.

The part of the Designation affected by this Notice is shown on the accompanying Requirement Plan and a shapefile has also been provided. The attached Requirement Notice refers to part of the area of land which is described as:

Removal of the designation is required as this land is no longer required in connection with a rail work.

Assessment under s185(5)

The designated site was purchased by Maurice Holdings Limited in July 2013 and has been in private ownership since that time. The land was then surplus to KiwiRail's requirements as there were no plans for developing it for railway activities. This remains the case.

The landowner has requested that the designation be uplifted.

In terms of s182(5) the effects of the removal on the rail work are less than minor, as the land is not required for a rail work. This action solely affects the landowner who supports and has requested the removal of the designation from the site. The owner intends to proceed on a redevelopment of the site.


