Subject: Plan Modification: Clause 20A modifications to Auckland Unitary Plan -

Correction to Schedule 10 and D13 Notable Trees Overlay, AUP

10 Margaret Road, Papatoetoe – ID #1787 (removal)

A correction is required to the Auckland Unitary Plan (operative in Part) 2016 (the AUP).

I seek your approval of this plan modification pursuant to clause 20A, First Schedule, Resource Management Act 1991 (correct minor errors) and Chapter D13 Notable Trees Overlay of the AUP(OP).

You have delegated authority, as a tier four manager, to make a decision to correct a minor error to an operative plan under clause 20A. Schedule 2A of the Auckland Council Chief Executive's Delegations Register¹ authorises all powers, functions, and duties under RMA's first schedule (except clause 17 which cannot be delegated) to tier four positions.

D13.4 Activity table of the AUP enables the automatic update of Schedule 10 Notable Trees Schedule under the following circumstances:

- a) Subdivision altering legal description of one or more trees
- b) Resource consent authorising the removal of one or more trees and the tree has been physically removed
- c) Resource consent for, or authorisation of, removal of tree as a result of emergency works (storm damage/disease/other).

In this case the modification arises from storm damage (circa April 2018) which has caused the tree to 'completely fail' according to West Fynn, Senior Heritage Arborist. He has recently reconfirmed that the tree has gone and this can be seen in the 2023 Satellite aerial photographs. While the listing is correct (and is to be deleted) the tree triangle is incorrectly located on the property to the rear of 10 Margaret Road so the 'before and after' graphic pertains to 105 Wyllie Road, Papatoetoe (**Attachment 2**).

Hi Yal

The Pohutukawa at 34 Tawa road in onehunga failed and I instructed them to reduce it to 4-5m in height leaving a stump to regenerate from under emergency works. So still retained and to be kept on the list.

The Lombardy at the front of 120A Gray Ave failed damaging the house and I instructed them to completely remove the tree under emergency works and therefore the Lombardy needs deletion from this listing but also the listing needs looking at as there is no listing for 120A but there is for 120? On GIS 120 is set back and there are not trees on all of the various 120's listed. If not one you have looked at then we need to review.

The oak at 10 Margaret ave, Papatoetoe was within that property and not in 105 Wyllie as GIS suggests and has completely failed and so needs removing from the list.

The pohutukawa at 11 woodford ave had significant failures into the road and I have instructed a reduction to 5-6m as emergency works with the remainder of the tree being retained.


