Summary

Auckland Council has received a request from New Zealand Transport Agency Waka Kotahi (NZTA) under section 182 of the Resource Management Act 1991 (RMA), dated 3 July 2024, to remove in part Designation 6761 – State Highway 1 - Silverdale to Puhoi.

A section 182(1) request is required to uplift the existing designation in in part from land which has been deemed surplus by NZTA.

Auckland Council, as the territorial authority, is required to amend its district plan, without using the process in Schedule 1, as soon as reasonably practicable after receiving a Section 182 request unless it considers that the effect of the removal of part of the designation on the remaining designation is more than minor.

It is recommended that the partial removal be accepted.

Recommendation

- That the section 182 request from NZTA for the partial removal of Designation 6761
 State Highway 1 Silverdale to Puhoi in the Auckland Unitary Plan be accepted for the following reasons:
 - i) NZTA no longer require the designation on the land; and
 - ii) The effects of the removal of part of the designation are less than minor.
- 2. That Designation 6761 State Highway 1 Silverdale to Puhoi be partially removed from road areas adjacent to 20 Fowler Access Road, Puhoi, as soon as reasonably practicable, in the Designation overlay and Chapter K Designations where the text needs to be amended in the Auckland Unitary Plan.

2. Background

2.1. Details of designation

New Zealand Transport Agency Waka Kotahi (NZTA) has served a notice under section 182 of the Resource Management Act 1991, signed by Sonya McCall, Team Lead of Poutiaki Taiao / Environmental Planning (dated 3 July 2024), to remove the designation from the sites identified in Attachment A to Attachment 1.

Designation 6761 in the Auckland Unitary Plan (AUP) is primarily located along the State Highway 1 from Bankside Road, Silverdale to the Johnstone Hill Tunnels. A small section of the designation covers the Old State Highway 1, ending at Titfords Bridge in Puhoi. The purpose of the designation is for motorway and limited access highway and associated interchange structures.

The designation is proposed to be removed from the land surrounding and immediately adjacent to 20 Fowler Road. Due to the revocation of the state highway status of the Old State Highway 1 between Puhoi and Warkworth on 30 June 2024, the areas identified within the designation are no longer required for the on-going operation, maintenance or mitigation of effects of the work authorised by the designation. The balance of Designation 6761 will be retained.

2.2. Land affected by removal




Figure 1: Designation 6761 in red, part of designation to be removed (green), as seen in the AUP maps

Figure 1 shows the part of Designation 6761 as shown on the AUP maps for removal. Designation 6761 is shown in red, with the section proposed for removal in green:

NZTA has provided a site plan showing the full extent of the designation and the sections proposed for removal. This is included in **Attachment 1**.

2.3. Delegated authority to consider alterations to designations

The Team Leader – Regional, North/West and Islands (Planning and Resource Consents) has delegated authority, in accordance with Schedule 2A of the Auckland Council Delegations: Chief Executive Officer (updated July 2024), to exercise the Council's functions, powers, duties and discretions under the Resource Management Act 1991 in relation to Section 182 to approve a removal of a designation.

The section 182 request to remove the designation can therefore be considered by the Team Leader – Regional, North/West and Islands (Planning and Resource Consents) and accepted or declined.

2.4. Relevant Statutory Provisions

Section 182 of the RMA allows a requiring authority to remove a designation or part of a designation if it no longer wants it. This section also applies to a notice by a territorial authority, to withdraw its own designation or part of a designation within its own district.

Section 182(2) states that as soon as reasonably practicable the territorial authority shall, without using the process in Schedule 1, amend its district plan accordingly. If the territorial authority considers that the effect of the removal of part of a designation on the remaining designation is more than minor, it may, within 20 working days of receipt of a section 182 notice, decline to remove that part of the designation.

It is considered that NZTA has provided sufficient justification for the partial removal of Designation 6761 – State Highway 1 - Silverdale to Puhoi for the following reasons:

- The removal of the identified areas does not affect the use of the rest of the designation for its intended purpose.
- Due to the revocation of the state highway status of the Old State Highway 1
 between Puhoi and Warkworth on 30 June 2024, the areas identified within the
 designation are no longer required for the on-going operation, maintenance or
 mitigation of effects of the work authorised by the designation.

3. Recommendation

That pursuant to Section 182 of the Resource Management Act 1991 that the partial removal of Designation 6761 – State Highway 1 – Silverdale to Puhoi be **accepted** and the Auckland Unitary Plan Operative in part designation overlay and text in Chapter K Designations be amended accordingly.





2. Background

2.1. Details of designation

New Zealand Transport Agency Waka Kotahi (NZTA) has served a notice under section 182 of the Resource Management Act 1991, signed by Sonya McCall, Team Lead of Poutiaki Taiao / Environmental Planning (dated 3 July 2024) for the partial removal of Designation 6763.

Designation 6763 in the Auckland Unitary Plan (AUP) is located along the old State Highway 1 from Titfords Bridge, Puhoi to Warkworth, and then followed the current State Highway 1 from Warkworth to Ross Road (Kaipara District Council boundary) in Topuni. The purpose of the designation is to provide for State Highway 1.

The designation is proposed to be removed in part from the sites identified in **Attachment 1**. Due to the revocation of the state highway status of the Old State Highway 1 between Puhoi and Warkworth on 30 June 2024, the areas identified within the designation are no longer

required for the on-going operation, maintenance or mitigation of effects of the work authorised by the designation. The balance of Designation 6763 will be retained.

2.2. Land affected by removal




Figure 1: Extent of Designation 6763 in red, with the black outline showing the designation extent proposed for removal.

The extent of Designation 6763 as per the AUP maps is shown in red in Figure 1 below. The part of the designation no longer required is the area is located in the area surrounded by the black outline:




Figure 2: Extent of Designation 6763 directly adjacent to 1378 Hibiscus Coast Highway Wenderholm, which is proposed to be removed in full.

Summary

Auckland Council has received a request from New Zealand Transport Agency Waka Kotahi (NZTA) under section 182 of the Resource Management Act 1991 (RMA), dated 3 July 2024, to remove in part Designation 6769 – Ara Tūhono – State Highway 1 realignment Puhoi to Warkworth.

A section 182(1) request is required to uplift the existing designation in part from land which has been deemed surplus by NZTA.

Auckland Council, as the territorial authority, is required to amend its district plan, without using the process in Schedule 1, as soon as reasonably practicable after receiving a Section 182 request unless it considers that the effect of the removal of part of the designation on the remaining designation is more than minor.

It is recommended that the partial removal be **accepted**.

Recommendation

- That the section 182 request from NZTA for the partial removal of Designation 6769

 Ara Tūhono State Highway 1 realignment Puhoi to Warkworth in the Auckland
 Unitary Plan be accepted for the following reasons:

2. Background

2.1. Details of designation




Figure 1: Part of Designation 6769 in red, with the area proposed to be removed in green, as seen in the AUP maps.

New Zealand Transport Agency Waka Kotahi (NZTA) has served a notice under section 182 of the Resource Management Act 1991, signed by Sonya McCall, Team Lead of Poutiaki Taiao / Environmental Planning (dated 3 July 2024), to remove Designation 6769 from the area identified in Figure 1 below.

Designation 6769 in the Auckland Unitary Plan (AUP) is located along the new State Highway 1 from Puhoi, north of Fowler Access Road to Warkworth. The purpose of the designation is for the construction, operation and maintenance of a State highway (Ara Tūhono - Pūhoi to Wellsford Road of National Significance: Pūhoi to Warkworth Section).

The designation is proposed to be removed in part from a part of the road reserve adjacent to 851 Pohuehue Road, Puhoi. Due to the revocation of the state highway status of the Old State Highway 1 between Puhoi and Warkworth on 30 June 2024, the areas identified within the designation are no longer required for the on-going operation, maintenance or mitigation of effects of the work authorised by the designation. The balance of Designation 6769 will be retained.

2.2. Land affected by removal

Figure 1 shows the relevant section of Designation 6769 (as shown on the AUP maps) in red, with the section proposed for removal in green:

2.3. Delegated authority to consider alterations to designations

The Team Leader – Regional, North/West and Islands (Planning and Resource Consents) has delegated authority, in accordance with Schedule 2A of the Auckland Council Delegations: Chief Executive Officer (updated July 2024), to exercise the Council's functions, powers, duties and discretions under the Resource Management Act 1991 in relation to Section 182 to approve a removal of a designation.

The section 182 request to remove the designation can therefore be considered by the Team Leader – Regional, North/West and Islands (Planning and Resource Consents) and accepted or declined.

2.4. Relevant Statutory Provisions

Section 182 of the RMA allows a requiring authority to remove a designation or part of a designation if it no longer wants it. This section also applies to a notice by a territorial authority, to withdraw its own designation or part of a designation within its own district.

Section 182(2) states that as soon as reasonably practicable the territorial authority shall, without using the process in Schedule 1, amend its district plan accordingly. If the territorial authority considers that the effect of the removal of part of a designation on the remaining designation is more than minor, it may, within 20 working days of receipt of a section 182 notice, decline to remove that part of the designation.

It is considered that NZTA has provided sufficient justification for the partial removal of Designation 6769 – Ara Tūhono – State Highway 1 realignment Puhoi to Warkworth for the following reasons:

- The removal of the identified areas does not affect the use of the rest of the designation for its intended purpose.
- Due to the revocation of the state highway status of the Old State Highway 1
 between Puhoi and Warkworth on 30 June 2024, the areas identified within the
 designation are no longer required for the on-going operation, maintenance or
 mitigation of effects of the work authorised by the designation.

3. Recommendation

That pursuant to Section 182 of the Resource Management Act 1991 that the partial removal of Designation 6769 – Ara Tūhono – State Highway 1 realignment Puhoi to Warkworth be **accepted** and the Auckland Unitary Plan Operative in part designation overlay and text in Chapter K Designations be amended accordingly.
