Subject: Plan Modification: Clause 16 amendment to a proposed plan change

Plan Change: 78

Auckland Unitary Plan (Operative in Part 2016)

I seek your approval to make an amendment to a proposed policy statement or plan pursuant to clause 16, Schedule 1, Resource Management Act 1991 (RMA). Clause 16(2) provides that:

A local authority may make an amendment, without using the process in this schedule, to its proposed policy statement or plan to alter any information, where such an alteration is of minor effect, or may correct any minor errors.

The RMA defines proposed plan at section 43AAC as follows:

- (1) In this Act, unless the context otherwise requires, proposed plan—
- (a) means a proposed plan, a variation to a proposed plan or change, or a change to a plan proposed by a local authority that has been notified under <u>clause 5</u> of Schedule 1 or given limited notification under <u>clause 5A</u> of that schedule, but has not become operative in terms of <u>clause 20</u> of that schedule; and
- (b) includes—
 - (i) a proposed plan or a change to a plan proposed by a person under <u>Part 2</u> of Schedule 1 that has been adopted by the local authority under <u>clause 25(2)(a)</u> of Schedule 1:
 - (ii) an IPI notified in accordance with <u>section 80F(1) or (2)</u>.

Plan Change 78 is a plan change to the Auckland Unitary Plan that has been notified but has not yet been approved under clause 17, Schedule 1, or become operative.

You have delegated authority, as a Tier 4 manager, to make a decision to amend the plan change under clause 16 where the alteration is of minor effect or to correct any minor errors. Schedule 2A of the Auckland Council Combined Chief Executives Delegation Register authorises all powers, functions, and duties under RMA's first schedule (except clause 17 which cannot be delegated) to tier four positions.

Nature of error or	The AUP maps has been recently updated in line with the Plan Change 30
alteration	make operative memo. This involved re-aligning the boundary of the Pukekohe Park Precinct to exclude land rezoned as part of PC30 (which was rezoned from the Special Purpose Zone to the General Business Zone). The request to update the precinct boundaries in the AUP maps as part of the memo was not actioned at the time the plan change was made fully operative.




	To ensure that the PC78 maps is consistent with the AUP maps, the same alteration as described above is required.
Effect of change	The request to alter the Pukokohe Park Precinct (on the AUP maps) was made as part of the PC30 make operative memo, but was only recently actioned.
	To ensure consistency between the AUP maps and the PC78 Maps, an alteration is required to ensure that the extent of the Pukekohe Park Precinct is correctly shown on the PC78 Maps, and does not cover the land rezoned as part of PC30.
	The alteration is considered to be neutral as its only purpose is to ensure that the PC78 Maps matches the AUP maps, and the Precinct Plan in Pukekohe Park Precinct.




Figure 1: PC78 maps showing Pukekohe Park Precinct in red




Figure 2: AUP map showing Pukekohe Park Precinct in red

Alter the extent of the Pukekohe Park Precinct in the PC78 Maps (Figure 1), to be consistent with the AUP maps (Figure 2).
