Plan Modification: Clause 16 Amendment to Special Character area map shown in Part 3 Chapter J 3.1.6.8, Proposed Auckland Unitary Plan.

This plan modification requires decision-making pursuant to clause 16 of the First Schedule as corrections are requested to a Proposed Auckland Unitary Plan provision.

Nature of change	Remove the sites 61-73 Davis Crescent, Newmarket from being identified as "sites with character defining buildings" and exclude the sites from the extent of the Special Character – Business Newmarket overlay from the Special Character area map shown in Chapter J 3.1.6.8.
	The sites are incorrectly identified as "sites with character defining buildings" and as part of the Special Character – Business Newmarket overlay in the map within the text of the Plan. However the sites are correctly excluded from this overlay in the planning maps (GIS viewer and hard copy – see attachment 1 map 2). As a result a user will get conflicting information about these sites depending on where they look.
