MAY IT PLEASE THE HEARINGS PANEL

1. Since its notice of requirement seeking the inclusion of designations in the Unitary Plan, dated 28 August 2012 ("**Rollover Notice**"), was lodged, it has become apparent that some designations, and parts of other designations, are no longer required for education purposes.
2. Accordingly, counsel confirms the following on behalf of the Minister:
 - (a) **Designation 4645**, 73-89 Moire Rd, Massey is withdrawn. This property is no longer required for education purposes.
 - (b) **Designation 4781**, 32-44 Luke St, Otahuhu is withdrawn. This property is no longer required for education purposes.
 - (c) **Designation 4977**, 51S Eugenia Rise, Manukau, is withdrawn. This property is no longer required for education purposes.
