Land slip remediation	Car Park Closures
activities on site	Works on site are progressing very well. The Project Manager has indicated that there is now an opportunity to start stockpiling earthworks materials on site to allow the project timeline to actually speed up. However, this will require an 'intermittent' closure of the car park once again (except the disabled parks).
	The earthworks material refers to the stockpiling of fill material that will be used in the gully during Phase 2. This will help bring forward the project programme so that works can finish earlier. Trucks with fill material are going to be making deliveries via the existing car park and new ramp down into the new site. To help the construction process go smoothly and safely, we will need to close the carpark to the public as these trucks are going to require room to manoeuvre.
	This is not the first time that the Rawene car park has needed to be closed to enable works on site to progress. However, we sympathise with the local community, businesses and residents, as we move into this part of the work which requires a lot more material to be delivered to site.
	When will the car park be closed?
	The car park will be closed from Monday mornings to approximately 12pm (midday) on Saturday each week. We are required to close the carpark during these evenings to ensure nobody parks overnight – cars that park overnight when the car park is closed will be towed away. Cars found in the car park could hold up truck deliveries each morning and slow progress on site.
	How will I know if the car park is closed?
	There will be a Site Traffic Management Supervisor (STMS) at the entrance of the car park directing traffic. Private vehicles will not be allowed into the car park. There will also be cones/barriers in place and signage. We have used this system previously on site.
	Construction times
	All vehicle movements, on and off site, are going to be restricted to normal construction hours (these times are also provided by the resource consent to carry out these works). These times are as follows:
	<ul> <li>Monday to Friday:         <ul> <li>6.30am to 7.30am, low level noise activities only</li> <li>7.30am to 6pm, construction work</li> </ul> </li> </ul>

	$\circ$ 6pm to 8pm, work can continue, but no noisy work
	<ul> <li>Saturday: 7.30am to 6pm (although work does not usually proceed after midday)</li> </ul>
	<ul> <li>Sundays and public holidays: No noisy construction work at any point. Site visits may occur on these days</li> </ul>
	How long will this take?
	The current programme has the earthworks finishing in early June 2019, however we aim to bring this forward and may be able to open the car park before then. We will simply keep people updated via these email updates and signage.
	Use of disabled car parks
	There are three Accessible (disabled) Car Parks in the Rawene car park that will still be made available during this time. These spaces can be accessed from Rawene Road.
	Car Park Time Limits
	Car park time limits still need to be adhered to during those times that the car park is open and Auckland Transport's parking officers will continue to enforce the time limits in the public car park.
	<u>Summary</u>
	We also expect that given all the usual constraints around construction work on site, there are bound to be days when work cannot proceed due to weather (especially in winter) or unforeseen circumstances, and every endeavour will be made to open the car park on those days. We will continue to update the community if this arises.

	Arborists will be on site on Friday 29 <sup>th</sup> March. Three trees are to be removed. They will be mulched on site and sprayed back onto the bank of the site. Some other scrub/bush will also be mulched. Dead wood/bush will be removed from the site at a later date.
	This work will start at 7:30am and may last until till 6pm (construction activities are permitted on site until 8pm on weekdays, however noisy work is restricted after 6pm).
