We're continuing to work as swiftly and effectively as we can to help progress the recovery efforts.

It was great to see one of these initiatives coming to fruition this week, with the government's [announcement of additional accommodation support for displaced residents](#).

This has come about due to some strong advocacy from the community, as well as behind-the-scenes lobbying from Recovery Office staff.

Finally, I wanted to note that public consultation began this week on Local Board plans for 2023. The Waitākere Ranges Local Board plan includes initiatives to support the recovery efforts, such as community resilience plans to help prepare for future emergencies, supporting the West Coast Gallery, and the restoration and enhancement of ecosystems in the Waitākere Ranges Heritage Area. Karekare cordon changes

The following changes to the cordon restrictions into Karekare came into effect from Monday 17 July:

- Lone Kauri Road - the current ‘soft’ cordon and residents only access restrictions was removed, allowing public access into Karekare.
- Karekare Road – the ‘hard’ cordon with manned security presence was reduced to a ‘soft’ cordon consisting of barriers and signage only, with residents only access to remain.

Weight and speed restrictions of 3.5 tonnes and 30km/h remain in place on both roads.

AT has advised there have been delays in obtaining appropriate signage to support these changes. Traffic management staff may be present at both points until new signage is in place.

Central Government Update

Temporary Accommodation Assistance for displaced homeowners

Yesterday the Government announced that from 4 September, people who were displaced from their homes by the extreme weather events earlier this year will be able to access interim financial support when their insurance payments for temporary accommodation run out.

How will it work?

Direct weekly payments will match your actual weekly rent, with different caps for different household situations:

Household situation	Maximum weekly payment
A couple with two or more children / a single parent with three or more children	\$610
A couple with one child / a single parent with two children	\$560
A couple with no children or a single parent with one child	\$480
Single person	\$330

Displaced families eligible for this payment can receive a lump sum payment covering them from as early as 1 June 2023.

Applications can be submitted through MyMSD from 4 September.

Am I eligible?

- You must have a tenancy agreement from before 19 July 2023, and have been displaced from the home you own following the extreme weather earlier this year.
- If you are still receiving temporary accommodation assistance from your insurer, you will only be eligible for the package once this cover runs out.

Auckland Transport (AT) update

AT has advised they will begin the next phase of permanent slip repairs in Karekare in approximately 6-8 weeks’ time, once designs are approved. Fulton Hogan will continue to undertake roading repairs in Karekare. Additional road closures and traffic management will be in place to support these works as and when they occur.

The initial phase of storm-damage related works has been completed, with some additional drainage works on Lone Kauri Road remaining. Preliminary safety and geotechnical investigations have been completed.

Geotech Update

GHD's current focus for Karekare is continuing to review property files and assessment of information gathered so far and providing evidence to support the review of RBA placards where possible. Field mapping and GIS database work has been completed.

Information that is being included in the above review and assessment includes LiDAR (which stands for 'Light Detection and Ranging'- a 3D remote sensing method that uses light to measure and produce pictures of the exact distance of an object), aerial photographs, desktop studies of available historical data, anecdotal evidence collation, reviews of geological maps and NZ Geotechnical Database, field mapping, geomorphological interpretation and assessment of Auckland Council information.

The methodology being used for by GHD is the [Australian Geomechanics Society Landslide Risk Management method \(AGS-2007\)](#). This method was originally developed in 2007 and is widely used as best practice by the geotechnical industry across New Zealand. This has been used in assessing land stability in other parts of the country, such as the Port Hills following the Christchurch Earthquakes. The system considers the individual likelihood of a landslide occurring, of it reaching a dwelling and of residents being impacted.

GHD has advised that the landslide risk assessment work is on track against the estimated timeline, which was outlined in the [25 May Newsletter](#).

Rapid Building Assessments (RBA) Update

Updated placard status numbers in Karekare as of Wednesday 19 July:

- Red 1 – 4
- Red 2 – 8
- Yellow 1 – 9
- Yellow 2 – 10
- White – 0

There are different reasons why these numbers may differ each week, including:

- If remedial action has been confirmed and approved by the council's compliance team, then the placard can be noted as closed and removed off the list.
- It is identified as a duplicate and removed.
- A building with multiple units was allocated a single placard when it should have had a placard allocated for each address.

NEMA's Cyclone Gabrielle Welfare Support Grant for Community Organisations Extended

The National Emergency Management Agency's (NEMA) Cyclone Gabrielle Welfare Support Grant has [extended its deadline for applications to 31 August](#).

The grant is available to reimburse costs already incurred by marae, iwi, and recognised community organisations (including rural groups, Pacific organisations, and ethnic service providers) to care for people who were affected, displaced, or isolated during the state of national emergency.

Over recent weeks, the Recovery Office has had conversations with Karekare locals about mental wellbeing courses, which are a great way to come together to learn more about mental health with others who are on a similar journey.

This course will be facilitated by the Red Cross for Piha and Karekare residents, and helps people manage their emotions and the responses that people around them have to a disaster.

As outlined on the [event page](#), "Come and unpack the science of stress and its impact on how we feel, function, and relate to others. The workshop provides practical tips and tools to help yourself—or those you're supporting—through the recovery process.

Learning outcomes

1. Understand the impacts on people after an event and recognise distress responses.
2. Be aware of responses in recovery.
3. Learn about Dr Rob Gordon's 'four processes of recovery'.
4. Be reminded of how to look after yourselves.

The course will run for 3 hours, please bring a drink bottle. Capacity is limited to 24 people. Due to activities the workshop can only proceed with a minimum of 10 people.

If there is demand, we will look to run another session for Karekare and Piha at a later date."

Waitākere Ranges Regional Park

Our staff are continuing to assess damage and accessibility, with a view to opening more areas as soon as possible, while considering the impact on the community. This includes geotechnical assessment on some tracks.

We ask the public to respect all closures and not remove any barriers or signage currently in place. This is for people's own safety, and to not add to environmental damage in the area, including the threat of spreading kauri dieback disease.

We continue to encourage visitors to check our [map of open and closed tracks](#) on the Auckland Council website before heading out.

Tracks that have recently reopened:

- Byers Loop (2 June)
- Mercer Bay Loop (17 June) – please note that Comans Track has a barrier in place (pink line in image below), as it still needs repairs.



Damaged tracks likely to reopen in the short to medium term:

- Comans Track
- Ahu Ahu Track
- Gibbons Track
- Muir Track
- Slip Track
- Caves Track (Whatipu)

Damaged tracks that will not be open for some time:

- Laird Thomson Track
- Tasman lookout Track
- Marawhara Track
- White Track
- Lion Rock Track
- Lake Wainamu Track (full loop)

Damaged tracks awaiting geotechnical reports:

- Gannet Track / Takapu Refuge
- Quarry Track
- Lookout Track
- Edwin Mitchelson Track
- Auckland City Walk

- Knutzen and Kitekite tracks (including access to Kitekite Falls)
- Zig Zag track

Please note no geotechnical reports for these tracks have been received, hence the lack of progress with these tracks.
