## 2023/2024 rates relief – how to apply

Last week, Auckland Council's Governing Body approved 100 per cent rates relief to all households that are uninhabitable as a result of extreme weather events in the first half of 2023.

We hope this support helps to ease the financial burden for those most severely impacted.

If your house was **red placarded** as at 30 June 2023, you will receive a 100 per cent rates relief for the full 2023/2024 rating year. A credit will be automatically applied to rates invoices, so you don't need to do anything.

Every property has a unique situation and some yellow and white placarded homes are habitable while others are not. If your home is uninhabitable, then please apply for rates relief using this [online form](#). We'll assess each application based on your personal circumstances.

## Have your say on storm recovery and resilience

Auckland Council is committed to supporting communities to recover and prepare for the future, and is seeking public feedback through several consultations.

There are three consultations where you can have your say on topics relating to the recovery, flood resilience and how we respond to emergencies:

- **Local Board Plans: 13 July to 14 August**
  - Contribute to the strategic, 3-year plans for your local area
  - Guide decision-making and reflect community priorities and preferences.
- **Auckland Civil Defence Emergency Management Group Plan: 1-31 August**
  - Help shape the 5-year plan that determines how Auckland prepares for, responds to and recovers from disasters.
- **Storm Recovery and Resilience: 3-31 August**
  - Provide input to the Tāmaki Makaurau Recovery Plan addressing Māori partnership, community, economic and environmental recovery

- Tell us your thoughts on Making Space for Water – council’s proposed focus area to manage our stormwater network and the region’s resilience to flooding.

You can submit your feedback on as many of these consultations as you wish.

## **Karekare and Piha ‘Have your Say’ event**

On Sunday 6 August, from 12.30pm-2.30pm, the Recovery Office and Healthy Waters will be hosting a roadshow drop-in event at the Karekare Surf Lifesaving Club for the community to provide input into the Tāmaki Makaurau Recovery Plan and Making Space for Water. In attendance will be representatives from the Recovery Office.

## **AT update**

Signage for Karekare and Lone Kauri Roads is currently being installed. Additional line marking on Karekare Road will also be put in place.

Geotechnical works have been completed, and a final option for repairs to Scenic Drive has been agreed, so works on Scenic Drive are expected to take place over the next few months. This includes the Elevation slip site.

AT will be working with private property owners around access before works begin.

## **Building assessments update**

Updated placard status numbers in Karekare as of Tuesday 1 August:

- Red 1            5
- Red 2            8
- Yellow 1        9
- Yellow 2        10
- White            0

There are different reasons why these numbers may differ each week, including:

- If remedial action has been confirmed and approved by the council’s compliance team, then the placard can be noted as closed and removed off the list.
- It is identified as a duplicate and removed.
- A building with multiple units was allocated a single placard when it should have had a placard allocated for each address.

## **Onsite wastewater systems**

Onsite wastewater systems require regular maintenance to make sure they operate correctly. Most modern systems require six-monthly servicing and inspections.

Once you regain access to your property, we recommend requesting an inspection and service of the system prior to use. This can be done through your own service provider.

The [council website](#) has information and guidance on managing wastewater on your property, as well as a list of service providers.

While the council's Safe Septic Programme maintains a register and regularly sends out reminder letters to property owners, contact with red and yellow-placarded properties has been put on hold for a 12-month period.

## **Community group funding available**

Community groups providing support to whānau and communities across the Auckland region following the January/February weather events, can now apply for Auckland Together grants funding. This fund was established by the Auckland Foundation to support communities following the 2023 storms.

Organisations working within the Auckland region can apply for this funding if they are providing:

- food, hygiene, clothing and other essential items to Auckland communities, whānau and individuals in need
- social support services to those affected
- outreach care for those now experiencing homelessness.

Requests can be made for grants of \$10,000 to \$50,000.

Applications for the August 2023 funding round have until 5pm, Friday 11th August to apply.

## **NEMA's Cyclone Gabrielle Welfare Support Grant for community organisations extended**

The National Emergency Management Agency's (NEMA) Cyclone Gabrielle Welfare Support Grant has [extended its deadline for applications to 31 August](#).

The grant is available to reimburse costs already incurred by marae, iwi, and recognised community organisations (including rural groups, Pacific organisations, and ethnic service providers) to care for people who were affected, displaced, or isolated during the state of national emergency.
