You are invited to attend the hearing where the Hearing Commissioners will consider submissions in support of/or opposing the application. Attendance via MSTeams is available on request, by contacting the hearings advisor by 12 noon Thursday 21 July 2022.

If no submitters on this application wish to be heard, the hearing will be vacated, and the matter determined on-the-papers.

Please note the commissioners may carry out a site visit, individually or together, either before, during or after the hearing which may involve them going on to the application site and, if necessary, submitters' sites. During the site visit, the commissioners will not speak to any of the parties directly about the application's merits.

The following apply:

- (a) **The Requiring Authority** is required to provide all its briefs of evidence by **Friday 22 July 2022 at 12 noon**.
- (b) **Submitter** evidence is encouraged to be pre-circulated and will be presented at the hearing
- (c) Any expert witness is required to provide:
 - 1 hard copy of the evidence at the hearing
 - 1 soft copy - briefs of evidence to be provided via email or on a data stick, each file should be less than 10Mb.

Any submitter who is providing a personal statement to read at the hearing, is encouraged to provide these electronically to the Hearings Advisor prior to the hearing if possible, as well as bringing 1 copy to the hearing. This will allow for contactless exchange of evidence and enable parties, whether in attendance or participating virtually to view the material prior to the hearing. If you have not provided the statement in advance of the hearing, please bring 8 hard copies with you.

- (d) A short-written summary for briefs of evidence in excess of 10 pages is helpful. It is likely the commissioners will request that this at least is read at the hearing.
- (e) The council will make available all reports and evidence on its website within 24 hours of receipt or as soon as is practicable. The link to the website is:

- (f) Email will be the address for service for the applicant and submitters, unless advised otherwise.
- (g) If the hearing is held virtually, or you plan to attend virtually, please ensure your evidence is provided to the Hearings Advisor electronically before the hearing commences. The panel members will have already read your original submission and they will have that in front of them at the hearing.

At the date of this letter Auckland is in the orange setting of the COVID-19 Protection Framework. There are restrictions with face-to-face hearings at this level that include:

- 1m social distancing required in public spaces such as the hearing room and foyer area. This is an Auckland Council requirement. This may mean there is a possible restriction on the number of people who can attend the hearing in person to ensure

social distancing is adhered to. The Hearings Advisor will discuss this with the parties before the hearing to ensure these requirements are adhered to

- use of a face-covering is mandatory at some indoor venues including premises operated by local government agencies. This includes the hearing venue
- no participants are to attend who have COVID-19 symptoms or who need to be in isolation/quarantine for any reason.

For those participants who cannot attend in person or who wish to attend virtually, please let the Hearings Advisor know by Thursday 21 July 2022 (or as soon as possible before the hearing) and they will send you a MSTeams link prior to the hearing.

Should it be determined at any time that it is not safe to hold the hearing face-to-face, the Hearings Advisor will contact you about how we will proceed with the hearing, which could be virtually via MSTeams.
