Please note the commissioners will carry out a site visit, individually or together, either before, during or after the hearing which may involve them going on to the application site and, if necessary, submitters' sites. During the site visit, the commissioners will not speak to any of the parties directly about the application's merits.

The chair has directed that evidence is to be pre-circulated for this hearing. In accordance with the Direction, evidence is due to be received by the Hearings Advisor as follows.

In accordance with the direction dated 31 March 2021 the following apply:

- (a) **The council** is required to provide its officer's reports and any evidence at least 15 working days prior to the date of the hearing. This report will be available on the council website no later than 5pm on Tuesday 10 August 2021.
- (b) **The applicant** is required to provide all its briefs of evidence by Tuesday 17 August 2021. You will be advised once the evidence is available.
- (c) **Any submitter** proposing to call expert witnesses is required to provide briefs of evidence from those experts. To ensure this evidence is available on council's website at the time directed, it is required by midday, Tuesday 24 August 2021.

The commissioners have requested that any submitter non-expert evidence be provided by midday, Tuesday 24 August 2021.

The hearing commissioners are also encouraging parties to pre-circulate their legal submissions. These are due with me no later than midday on Tuesday 31 August 2021.

The submitter is required to provide:

- 12 hard copies of the evidence
- 1 soft copy briefs of evidence to be provided via email or on a data stick, each file should be less than 10Mb.

- (d) A short-written summary for briefs of evidence in excess of 10 pages is helpful. It is likely the commissioners will request that this at least is read at the hearing.

If you plan to present a submission or evidence, please make at least **12 copies** available at the time of the hearing for the panel members, applicant and for other parties who are likely to attend.
