Hi Jo,

As far as the HIF projects go, I would say it comes down to the same key theme, in terms of the inter-dependence with others of the NOR routes within the network, and understanding the performance of individual corridors in isolation, without the wider network.

In the case of the 4 Redhills HIF NORs (1, 2a, 2b, 2c), I would consider that the interdependence element is limited to the interdependence between these 4 separate NORs themselves – but is of relevance, as the four are each separate NORs.
