RE: Withdrawal of Part of Proposed Plan Change 60 - Open Space (2020) and Other

Rezoning Matters

Withdrawal of part of Proposed Plan Change 60 – Open Space (2020) and Other Rezoning Matters (PC 60) to the Auckland Unitary Plan (Operative in part); Pursuant to Clause 8D of Schedule 1 of the Resource Management Act 1991.

Clause 8D of Schedule 1 of the Resource Management Act 1991 enables the withdrawal of parts of a council initiated plan change.

Under delegated authority through Schedule 2A of the Auckland Council Combined Chief Executives Delegation Register (updated August 2018), delegated managers are empowered to make decisions on specified Schedule 1 matters. These include withdrawing parts of a proposed plan change.

Proposed amendments to be withdrawn from Plan Change 60	Proposed Plan Change 60 involves amending the zoning of land at 106 different locations. In some instances, these locations involve more than one land parcel. The changes in zoning relate to either the vesting or acquisition of new open spaces; the correction of zoning errors or anomalies; Panuku's rationalisation of the zoning of land prior to its disposal/sale; or the rezoning land parcels or groupings of land parcels to enable redevelopment by Kāinga Ora, to improve the quality of open space/access to open space or in the case of privately owned land, to better reflect its current use as for example, a golf course or cemetery. It is proposed to withdraw the following Panuku changes: • Map 83 - 30 Willerton Avenue, New Lynn (Lot 4 DP 38999)
