Recap

- Clarification was needed on the purpose of an open space network plan – particularly in relation to a Local Parks Management Plan.
- Staff provided a one pager with options analysis, recommending Option B - Develop a skeleton Open Space Network Plan that includes key moves and prioritisation principles but excludes a park-by-park analysis.
- Local board agreed, as long as the revised document is clear about gaps in the network.



Recap: alignment with Local Parks Management Plan

Open Space Network Plan

Open Space Network Plans are **non-statutory** documents that set out the aspirations of the local board for the future development of the open space network. They create a cohesive view of the open space network and provide decision-makers with a tool to prioritise budget allocation.

Open Space Network Plans include

- an assessment of open space provision including principled opportunity for acquisition/optimisation/reconfiguration of parks as per the <u>Parks and Open Space Acquisition Policy 2013</u>.
- advocacy actions to the governing body or stakeholders.

The plans aim to be a 10-year living document and can be **subject to review** by the local board. OSNP are concise, high-level documents that cover three main sections: current state, key moves and prioritisation principles and actions.

Local Parks Management Plan

Local Parks Management Plans are **statutory** documents that set local boards and public expectations about how individual parks are used, managed and protected. The plans address what needs to be considered when developing and enhancing our parks. The plans are **developed with** mana whenua and **consulted on** with the local community to ensure their needs and aspirations for local parks are considered.

Local Parks Management Plans are detailed documents with two volumes, four sections and appendices spanning approximately 500 pages.

The Kaipātiki Local Parks Management Plan is currently on hold (as per memo dated 18 August 2021 to the local board) and is estimated to be nearing completion at the end of 2022. As the notifications of the draft plan and subsequent hearing are likely to be around the election period, staff will need direction from the local board on timing to finalise.

Prioritisation criteria

- existing capital works programmes and contractual commitments
- areas zoned for high growth (metropolitan centre, town centres, local centres, mixed use, terrace housing and apartments) and areas where is a gap in provision has been identified
- areas of deficiency and/or poor-quality open space are prioritised over areas of good provision and/or good quality open space
- alternative options that still deliver high benefits for the community
- planning and funding cycles and other influences such as land acquisitions, large infrastructure projects, integrated planning with neighbouring local boards and other stakeholders.
