


COMMENTARY

For the month of July, a decrease in requests for service has been noted, however it is a significant increase when compared with this time last financial year.

Structure Maintenance and Repairs remain the highest, followed by Plumbing Maintenance Service. Tree Maintenance has dropped out of the top three for the first time this calendar year.

Electrical Maintenance Service has increased and now appears in the top 5, this is resultant from the electrical issues being addressed in our built space.

COMMENTARY

148 audits were conducted for the month of July and the audit scores have hit a high of 95% - very similar to this time last financial year.

A continued trend in the top 3 are Toilets, Sportsfields and Response Work Orders.

Lowlights for July include Turf, Tracks (incl. structures) and Hard Surfaces and Paths. This is ongoing work to bring these assets back into specification due to the two major storm events which occurred earlier in 2023.

Treescape has done well at getting these down and they are now in their 10s across Treescapes area. The ones left are still larger jobs but are also less significant in nature though still doing. Winter has made it hard to work in parks so some locations have debris left behind which will be picked up when conditions are more suitable.

Scheduled Pruning


This has been taken up again with some fervour as keeping our tree stock well maintained and inspected can help lessen the aftermath of future weather.

RFS Backlog

While this is still a little higher than two times the business-as-usual average, it is now at a level that is manageable for our contractor. Some pressure is off, and an amount of breathing room has been accomplished. There is still some work to go but a level of recourse flexibility has been achieved.

Planting

It has taken longer than expected to get to the western and northern boards due to the new trailers needing final touches. However, with planting completed elsewhere in Auckland the contractors were able to get through a lot of these more remote areas in a very short time. The odd location still requires planting but for the most part it is starting to look complete.

Harold Moody- Playspace Renewal

Physical works for the playspace renewal at Harold Moody were completed in early July.

The new equipment includes a play module, swing set and balancing activity. The play module includes a double slide and single slide, spider web, monkey bars, steppingstones and scaling wall.

We have also included two new swing bays, one of which is a basket swing with access via an accessible ramp and surfacing. To further improve accessibility, we have added a pram crossing from the carpark.

To optimise play value within the tight budget we were able to reuse the tunnel from the original play module and incorporate it in with balance beams to create a crawling and balancing activity.













Ökaurirahi / Ceramco Function Centre – accessibility improvements and changes

Ōkaurirahi / Ceramco Function Centre a section of the path and kerb have been removed to allow for the installation of a new kerb ramp to provide accessibility from the carpark to the footpath.

Concrete will be poured early August (weather permitting), along with the new kerb ramp.

A new accessible parking space will be installed, and new signage strategically placed to assist directing the public to the new accessible toilet.

Community Leasing

Community lease movements

- Applications have been sent to all groups on the 23-24 Work Programme for new leases and renewals
- Titirangi Badminton Club has applied for a new lease to continue occupation and operation from the site for a further 10 + 10 years. A site visit has been done. The group have proposed to extend the badminton courts which would be a significant project. They have been sent Landowner Approval application in the first instance and will apply when they are ready. Depending on when they apply, the new lease with an extended footprint will be discussed with the Local Board alongside the proposed new build (together with Land Advisory), or it will be proposed prior to it reaching the Land-owner Approval stage, which will require a Deed of Additional Premises to be entered into at a later date.
- The Roundabout Society have applied for a lease renewal for a term of 5 years. The building is council-owned and tends to have a significant amount of mud and pooled water around it during the winter months, therefore we have requested an asset assessment before we proceed. A site visit has been planned for late August.
- Plunket located inside the Titirangi War Memorial Hall has applied for a new lease to continue occupation and operation from the site for a further 5 years. The building is council-owned. An asset assessment was requested and completed in July 2023. There was some damage from the February floods which has been fixed. A site visit has been planned for September.

Land Advisory

Land-owner applications received are assessed by Land Use Advisory and reviewed by Community Facilities staff. The board will be contacted for feedback in due course.

 There are no Land-owner Applications received to report for the month of July.



PARKS AND PLACES SPECIALIST UPDATE



Bethells Surf Club Relocation Proposal

Staff continue to work with the Bethells Surf Club to ensure continuation of service at Te Henga.

Short Term: Club continue to operate out of building and are investigating alternative landholdings. Staff will assist on solutions if building becomes untenable.

Long Term: Club have submitted an LOA application. In order to provide quality advice, we must undertake:

- Location / Parks Impact Assessment
 - Park user analysis data gathering
 - Mana whenua and stakeholder consultation
 - Possibly some design work
- Lease Assessment / SME input
 - Coastal, tree owner, ecological
 - Consultation and notification
- LOA and Approval to Lease granted
- Club progress funding, design, consent, construct.

 - ✓ Barriers
 - ✓ What makes a greenspace attractive to go too
 - ✓ What does the best playground in the world look like



- ✓ Second visit
 - ✓ Introduced Actionbound
 - ✓ Built a simple course together. HIGHLIGHT: the students from Prospect School completed the course from the school, down through Kamara Walk to Prosect Park. On completion some of the ākonga said they had never been to Prospect Park.
 - ✓ Ākonga at Konini designed their own without my help ☺



Deliver a range of activations and events in local open spaces such as: Wirihana Reserve, Kowhai Reserve, Kaurimu Park, Swanson Reserve, Kamara Road Common, Claridge Street Common, Harold Moody Park

- ✓ Having had two visits with the schools we have starting developing what the next visit will look like:
 - Students will design an Actionbound Course
 - The course will take us to the closest park to the school
 - It will have at least two stages to it
 - Lastly, it can be done by the rest of the school

Looking forward 2023 - 24

- ✓ Create a stronger ties with Tē Kawarau a Maki
 - Use of digital platform to enhance and engage tamariki and rangatahi with local mana whenua

 - If appropriate, attach Māori Stories to the park
 - Work with Te Kawarau a Maki and Waitākere Ranges Local Board to achieve quality story telling experiences at the parks having English names replaced. Plus dual name adoption at identified parks in the area.
- ✓ Work with WRLB to gain further insight, youth, club and community voice to create better parks and greenspace experiences.

Context

- Climate Action Programme aims to catalyse community action aligned with priorities in the draft Climate Action Plan
- Community Waitakere awarded \$40k contract in Dec 2022, and developed and delivered 2022/2023 activation programme from Jan to June 2023.
- Climate Action Activation progressed in parallel with finalising the Climate Action Plan
- The board has allocated \$32k for Climate Action Programme in 2023/2024



Activity in 2022/2023 Mātauranga māra - funded through **Auckland Climate Grant**

Climate activator role:

Built relationship with Te Kura Kaupapa Māori o Hoani Waititi Co-developed a programme arising out of their need Applied for Auckland Climate Grant funding (successful) Applied for top-up funding from Healthy Families (successful) Supported administration

Waitākere Ranges Local Board funding of \$2,000 to continue programme (Lisa Howard-Smith)

What happened?

- Five wānanga site visits; four local working bees
- Between 6 16 students at each workshop
- Six students supported financially
- The programme included kai for participants and host, koha to host for sharing their knowledge and time and also van transport to allow the group to reduce emissions by carpooling to venues.

Learnings

"Using compost and making own fertilizer instead of purchasing (creation and transport creates emissions)"

"How important our soil is. Its role in taking out the carbon in our atmosphere. We need to make sure there's lots of biology in our soils - all those microorganisms etc. To make healthy nurturing kai our soils need to be full of life"

"Urban farming knew nothing about it. Still lots to learn. Growing local, to local people etc. will help with climate change"

"Different kinds of composting system that can be used to reduce the methane output of biodegrading plant material"



Desire to keep going!

"He kaupapa rangatira teenei! It is crucial that we connect to the taiao for the survival of our species and Papatuanuku. The knowledge handed down to us is more relevant now than ever"

"This course has increased my activism for kaupapa Taiao/Papatuanuku/ climate change/ soil health/ matauranga retention and reclamation/ #hokiwhenuamai etc."








Toitū te whenua Outcomes

- Engaging with large Māori communities and local Glen Eden communities
- Both kura invited, as well as Glen Eden Primary School, Aiga Salevalasi Pre-School, and promotion with Glen Eden Library
- Food scrap bins included with bins in the kitchen so people saw them and used them
- Participants keen for more free, family-focused events more often e.g. quarterly (\$4,000 for event organiser's time so \$16,000 for 4 events)
- Feedback on aspects of climate change gathered and used to inform climate action plan



Activity in 2022/2023: Climate action microgrants

Climate Action Microgrant – groups with a focus on Māori and Pasifika rangatahi

Hoani Waititi kura invited, although unable to participate

Tongan Youth Trust participated – west-focused organisation




Met up with Glen Eden Business Association. Created a workshop for businesses that are west-based with Sustainable Business Network.






Purpose



Background

- Significant number of Council public trees near power lines
- Risks of foreseeable outages from trees near powerlines
- Increased risk during storm events
- Made worse by climate change





April 2018 storm

- 30% of the region without power
- Worst power network damage in two decades
- Review undertaken of the current approach to management of trees near power lines

- There is also a need to grow and protect the urban ngahere (aligned with Auckland's Urban Ngahere (Forest) Strategy)







First step - Vector Proposal

- June 2020 Vector approached Auckland Council
- Vector proposed an enhanced risk based approach to tree maintenance to achieve:
 - improved health and safety outcomes,
 - mitigation of future ratepayer costs,
 - greater efficiency, and
 - better tree resilience/amenity







Key Features of the Electricity Network Resilience Targeted Rate


- Introduced in 10-year budget 2021-2031
- Funding of \$10.5M per annum for four years
- Joint governance between Auckland Council and Vector
- Enhanced risk based approach to tree management
- Growing Urban Forest





Enhanced risk-based tree maintenance


- Balance between the needs of tree amenity/resilience, public safety and the resilience of the electricity network.
- This may include some of the following options:
 - open sky pruning
 - widening the distance between the tree canopy and the network
 - canopy height reduction
 - tree removal in certain cases












Tree Planting Programme

- \$2M funding annually (\$0.5M from ENRTR targeted rate)
- 4,000 trees (1,000 annually)
- Tree planting budget has been tripled by contribution from ENRTR





Tree Planting Programme

New tree planting is strategically delivered in areas of:

- low canopy cover and
- high heat vulnerability.

to:

- Increase canopy cover
- Reduce heat vulnerability
- Improve Biodiversity and Amenity
- Improve Green Space Equity



Summary

- Electricity Network Resilience Targeted Rate (ENRTR)
- Improved management of Council trees near power lines
 - Increased amenity/resilience of trees
 - Reduced foreseeable power outages
- Increased canopy cover in areas of need







Resource consenting

- On occasion individual resource consents are required for tree trimming under the enhanced risk based approach
- In significant ecological areas (such as in the Waitākere Ranges and on Waiheke Island) blanket tree trimming consents have been sought by Auckland Council for council-owned trees and concurrently by Vector for private trees
- The conditions of the resource consents place limitations on when work may be carried out during the year and how it may be carried out to protect fauna and flora (e.g. birds, bats, lizards)
