

Written summary of the Ordinary Business Meeting of the Devonport-Takapuna Local Board held at Devonport-Takapuna Local Board Office, 1 The strand, Takapuna on Tuesday 20 October 2020

This written summary was prepared by staff following the business meeting to fulfil legislative compliance under the provisions of S47A of the Local Government Official Information and Meetings Act 1987, as inserted by the COVID-19 Response (Urgent Management Measures) Legislation Act 2020.

Item 1 Welcome

Chairperson Aidan Bennett declared the meeting open and welcomed everyone attending. Member Toni van Tonder followed this with a karakia.

Item 2 Apologies

All members of the Board were present, and no apologies were received.

Item 3 **Declaration of Interest**

There were no declarations of interest.

Item 4 Confirmation of minutes

The minutes of the 15 September 2020 meeting, including the confidential section were confirmed as true and correct.

Item 5 Leave of Absence

There was no leave of absence.

Item 6 Acknowledgements

Member Jan O'Connor addressed the meeting to acknowledge the passing of former North Shore City Councillor & Takapuna Community Board Member Kenneth McKay who was a prominent member of the North Shore community.

Norma Bott and Debbie Dunsford (co-chairs) were in attendance to present on behalf of the Milford residents association to express concerns about maintenance in the local board area.

Roger Brittenden was in attendance on behalf of the North Shore Cricket Club to address the board about weed spraying on Devonport Domain. Roger

expressed frustration that the spraying has not yet been completed and requested further action.

The Elected Member Relationship Manager for Auckland Transport was in attendance to support this item.

Deputy Chairperson George Wood moved an amendment by addition and included recommendations b), c) and d). Chairperson Aidan Bennett requested that recommendations b) and c) be voted on by division. The motion was carried.

The meeting adjourned at 3.23pm and reconvened at 3.28pm.

Item 14 Local board views on plan change to enable rainwater tank installation for the Auckland region

The Auckland wide Planning Manager and a Healthy Waters representative were in attendance via Skype for Business to support this item.

The Local Board showed support for the proposed change.

Member R Jackson moved an amendment by replacement to the original motion which was voted on by division and failed when the Chairperson used his casting vote against the amendment.

The original motion was then voted on by division and passed when the Chairperson used his casting vote for.

The board resolved to form their feedback at a workshop and then have their feedback formally endorsed at their November 3 Business Meeting.
