

Written summary of the Ōrākei Local Board meeting held online in the Ōrākei Local Board office, and online via MS Teams on Thursday, 18 August 2022

This written summary was prepared following the business meeting, to fulfil legislative compliance under the provisions of S47A of the Local Government Official Information and Meetings Act 1987, as inserted by the COVID-19 Response (Urgent Management Measures) Legislation Act 2020 and the Board's resolution from its 16 April 2020 meeting as below:

Item 8.1 Deputation - Mission Bay Kohimarama Residents Association-Presentation on Tagalad Reserve Community Proposal

Wanda Mountfort, Don Stock and Robert Falvey presented to the board on behalf of the Mission Bay Kohimarama Residents Association regarding a proposal for repurposing Tagalad Reserve, with the key themes being "sustainable, social, and active". They discussed the potential for the current buildings and activities that could be undertaken using the open space, such as fly fishing. They also talked on the consultation results from the open day at Tagalad, where there was a large majority in support for retaining Tagalad as a community asset. A summary of the possible financial outlook and implications were also presented.

The board thanked them for attending and with the agreement of the meeting, an addition was made to resolution b to highlight that the board has made previous requests for advice on how Tagalad can be brought back under the boards governance. The motion was carried
