Subject: **Plan Modification: Clause 20A Amendment to Chapter I of the Auckland Unitary Plan (AUP) Operative in part (15 November 2016).**

Delegated authority to T4 manager through Schedule 2A of the Auckland Council Combined Chief Executives Delegation Register (Updated May 2017).

This plan modification requires decision-making pursuant to clause 20A of the First Schedule to the Resource Management Act 1991, as corrections are required to the Auckland Unitary Plan (Operative in Part).

<b>Nature of change</b>	<p>A minor change is required to correct text to the Operative in Part version.</p> <p><b>Discussion</b></p> <p>There is an error in the page headers and footers of the Highgate Precinct.          Page 1 does not have a footer. On pages 2-10 the footer reads:</p> <p style="text-align: center;">‘CONFIDENTIAL: I551 Highgate Precinct’</p> <p>The precinct is not confidential and therefore the footer on all pages should read:</p> <p style="text-align: center;">‘Auckland Unitary Plan Operative in part’</p> <p>There is an additional error in the page numbering format; which is written in the layout of, for example, ‘Page 2 of 10’ instead of just ‘2’. This is not consistent with the format of the plan.</p> <p>The header is currently missing from the document and should read ‘I551 Highgate Precinct’ as per the rest of the precinct text in the plan.</p>
<b>Effect of change</b>	The change is minor in nature. The amendment does not change the application or intent of the provisions but rather it ensures the correct administering of the plan as was originally intended. There is no effect

	nor impact upon either the environment or persons.
<b>Changes required to be made</b>	<p>Amend the footer on pages 1-10 of the I551. Highgate Precinct in the Operative in Part version, as shown:</p> <p><del>CONFIDENTIAL: I551 Highgate Precinct</del></p> <p><u>Auckland Unitary Plan Operative in part</u></p> <p>Amend the page numbering format on pages 1-10, from 'Page X of 40' to '<u>X</u>'.</p> <p>Include header on each page to read 'I551 Highgate Precinct'.</p>
